At its last meeting on 31 May, AARES Council approved the draft Memorandum of Understanding with the Australian Agribusiness Association (AAA). We have agreed on a cooperative alliance with the AAA which it is hoped will be to the benefit of both organisations. Areas of cooperation will include advice to members about events of interest being run by the other organisation, the conduct of joint events when appropriate, and joint activity in publishing and maintenance of web pages where economies can be realised. AAA is already publishing the journal "Connections" on behalf of AARES, which focuses on issues not covered by current AAA publications and the AJARE. The agreement will be in place for three years initially, and at that time its extension will be subject to review by both parties. We have suggested to branches that they try to involve AAA members in branch activities where appropriate. The AAA has e-mailed a notice to all AARES members about their annual Research Forum which is to be held on November 12 and 13 of this year, and AARES members are invited to submit abstracts of papers they would like to present at that meeting which is to have a focus on prospects for agricultural commodities. This appears to be a productive step both in terms of improving the flow of information to AARES members as well as widening the influence of the Society.

Many people are unaware that AARES has a membership category of "Emeritus" for retired AARES members. The membership subscription is the same as for student members, which is set at one-half of the rate for full members. We feel that it is important for the Society to maintain the participation of older members so we are drawing attention to the possibility for retired members to retain their membership and

register for the AARES Annual Conferences and Annual Symposia at a reduced cost. To qualify, you must have been a financial member for the 10 years preceding your retirement. To apply, you need only indicate that you wish to renew as an "Emeritus" member when you complete your next membership renewal form for Blackwell.

Council also decided to increase AARES membership fees from 2003. It has been several years since fees were last increased and inflation has continued to increase the costs of running the Society. We felt that we had no option but to increase fees which provides the bulk of the Society's revenue. Full membership subscriptions will rise from A\$80 to A\$90, while student and emeritus subscription will be A\$45, up from A\$40.

Finally, you will see in other parts of *News & Views* notices about the 2002 AARES Symposium which is to be held at the University of New England, Armidale, in conjunction with the "John L. Dillon AO Commemorative Day". I hope to see you there.



The Events

The 5th Annual AARES Symposium entitled "The US Farm Bill and Implications for Agricultural Trade" will be held Thursday 19th September 2002 at Lecture Theatre 4, Faculty of Economics, Business and Law, The University of New England, Armidale, NSW. The John L. Dillon AO Commemorative Day on "Agricultural Research: Challenges and Economics in the New Millennium" will follow on Friday 20th September 2002 at the same venue.

The new US Farm Bill will have important impacts upon international agricultural trade and the pace of international agricultural trade reform. It is a complex piece of legislation and analysts are hard at work at understanding its full ramifications. The 5th Annual AARES Symposium will focus on understanding the nature of the Farm Bill and what it means for those involved in international agricultural trade, including farmers, consumers, agribusiness firms and policy makers. In addition to expert speakers from Australia and New Zealand (ABARE, farmer organisations and universities), experts from the US will address the Symposium (confirmed to date are University of California at Davis Professor Daniel Sumner, Fulbright Senior Specialist and former Senior Staff Economist on the US President's Council of Economic Advisors; and Virginia Tech Professor David Orden, co-author of the recently published "Policy Reform in American Agriculture: Analysis and Prognosis"). There will be ample time for airing of alternative viewpoints and general discussion. It is also expected that very recent changes to the Common Agricultural Policy will receive some attention.

The John L. Dillon AO Commemorative Day is intended to acknowledge the outstanding contributions that the late John Dillon made to the national and international community, particularly his contributions in the way of fostering agricultural research and development that was his main interest during the latter part of his career. There will be a variety of national and international speakers who will provide accounts of the challenges facing agricultural research as we enter the New Millennium.

On the night of 19th September a dinner will be held for those attending one or both days. Jack Lewis, founder of agricultural economics at UNE, will be the after-dinner speaker so this will be a memorable occasion.

Registration Fees

The registration fee (inclusive of GST) for the Symposium is \$210 for Ordinary members and \$105 for Student members and Emeritus members, with a \$20 surcharge for non-members. The ACT Branch of AARES invites you to attend a half-day symposium on the topic of

'Property rights and the rural environment – beyond the textbook'

The debate between government, farmers and conservation groups over what constitutes a landholders 'duty of care' with regard to the provision of public environmental goods is reaching fever pitch. The National Farmers Federation has declared that it is giving property rights the highest priority this year (Weekend Australian, 8 June 2002). Similarly, conservation groups such as the World Wildlife Fund and Environmental Defenders Office are stepping up their involvement in formulating a view on property rights.

New environmental legislation – both at state and federal level – is prompting landholders to question what their land ownership rights convey. Policies involving environmental targets, credits and offsets strike at the very heart of the debate because these instruments require explicit definition of rights — which contrast with the historical case where landholder rights have been largely implied. What are the key issues of this debate and what insights can the environmental economics profession bring to the table? That is the focus of this half-day AARES symposium.

Research and Extension: As Easy as Walking and Talking!

We are very pleased to have received supportive feedback from a number of members about our first two issues. Thank you to those people for commenting and thanks again to the authors for making the issues possible.

Some feedback suggests that some articles are a bit too long; others are quite happy to dig into the detail. Like Goldilocks experience with the Three Bears chairs, it's not easy to get it 'just right'. We find that we need to work on three fronts: *converting* research into extension from AJARE or AARES conference contributions, *commissioning* articles from new non-AARES research reports and *hunting* and *gathering* from current forums where material is under-extended. A pleasing occurrence is when members phone to discuss their idea; editors really enjoy that sort of call!

While still in pilot mode you can expect us to be reasonably flexible about length and style. We think that 2000 words is a good length, but some contributions have come in excess of 3000. The integrity of the article and the style probably count for more with us than length, where you can expect to see a range. If we were burdened with contributions we may be able to cull contributions on length. But it's not like that!

So, what we are aiming to do is to collect a handful of extension style articles which may include some long, some short and some mid-sized. As we are not in the business of making work for ourselves we prefer

authors to modify after we have had a read, but we also make offers to do some editing to help the process along. Churchill used to write about seven drafts on his speeches. We would like to keep our iterations with authors to less than that. None have reached seven yet!

We have a number of articles in hand for the Winter issue and in process for the Spring issue. Topics include exotic livestock disease economics, natural resource accounting, dairy research and extension, farm adjustment, food scorecard, wool marketing, egg marketing, and farming systems.

If you have found the website (http://www.agrifood.info/Connections/index.htm) and enjoyed reading any articles spare a thought for writing one. Feel welcome to pick up the phone and talk about it before keying it. Remember, research and extension are a lot like walking and talking: it's possible to do both at the same time!

Applying Economics to Natural Resource Management

The Commonwealth, States and Territories have agreed to establish a new \$10 million program to look at how the marketplace might help conserve and sustain Australia's natural resources. The Natural Resource Management Ministerial Council, which is made up of Australia's environment and agriculture ministers, launched the *National Market-Based Instruments Pilots Program* on the 21st June, 2002. The Council invited applications for funding to run pilot projects testing the use of market mechanisms such as trading schemes, auctions and price signals to encourage better management of natural resource issues like salinity, waste water and vegetation management.

Co-chairs of the Council, the Minister for the Environment and Heritage, Dr David Kemp, and the Minister for Agriculture, Fisheries and Forestry, Warren Truss, said the *National Market-Based Instruments Pilots Program* also aimed to stimulate public debate on the issues.

"Market-based instruments (MBIs) work by using market signals to encourage more sustainable practices, and are a widely used tool for natural resource management in some countries," Mr Truss said. MBIs may include creating new markets or removing existing barriers to market activities. An example is the 'cap and trade' mechanism that is used successfully in the Murray-Darling Basin to encourage water trading. This is

when governments determine the overall allocation of water for irrigated agriculture in a certain region, and landholders can trade with other landholders if they find they need more or don't need as much water as they are initially allocated. "The Natural Resource Management Ministerial Council is keen to explore the potential of the market to encourage action to reduce salinity, improve water quality and conserve biodiversity," Dr Kemp said.

Dr Kemp also said some overseas and Australian State governments 'auctioned' funding for environmental work. "In these cases, governments go to the marketplace with a list of environmental outcomes they want to achieve – such as conserving a number of hectares of native bushland or planting a number of trees – and invite landholders to bid for funding to undertake this work. "In this instance governments are buying environmental outcomes and the market is dictating what it costs to achieve them. This system replaces traditional grants programs and benefits landholders who want to undertake this work as a part of their overall land management strategies, while determining the true cost."

Dr Kemp said governments could use MBIs to regulate wastewater discharge into waterways. This would work by limiting the total discharge from all industry in a region to a level that was environmentally sustainable, then creating a market system where companies could trade their rights to discharge. "Apart from taxes and subsidies, Australia is still at an early stage in developing and using MBIs. Many schemes are still being designed or have only recently been implemented," Dr Kemp said. "MBIs are not a quick fix, and many require legislative underpinning and support. There is still much to learn and all jurisdictions are facing the same questions about their practical application. Nevertheless, it is clear that MBIs have huge potential to achieve 'more from less', to drive innovation, place environmental considerations in the mainstream and give economic incentive for good natural resources management," Dr Kemp said.

The National Market-Based Instruments Pilots Program will be implemented in two phases. In the first phase \$5 million will be allocated to pilot projects over about two years. If this is successful, a further \$5 million may be allocated for further pilots. Mr Truss said the Program was part of the joint Commonwealth, State and Territory \$1.4 billion National Action Plan for Salinity and Water Quality. The call for initial proposals closed on 22 July. There has been great interest from around Australia, with over 300 people enquiring about the Program and subscribing to the mailing list to stay up-to-date on the Program's progress. Dryland Salinity: Economic Issues and Farm, Catchment and Policy LevelsFremantle, Australia 11 February 2003

Dryland salinity is one of Australia's most intractable resource degradation problems, affecting agricultural industries, biodiversity, water resources and infrastructure. There is extensive interest in and debate about the most efficient and effective approaches to management and to policy.

This one-day workshop, convened jointly by the Australian Agricultural and Resource Economics Society (AARES) and the CRC for Plant-based Management of Dryland Salinity, will address current economic issues in salinity management and salinity policy. Delegates will learn about the latest thinking and analysis on a variety of salinity related topics, will have the opportunity to discuss and debate the issues, and will receive a proceedings of the papers presented.

Indicative Topics

- Introduction: What are the issues?
- Principles for the combination of hydrology and economic models
- Methodology for dealing with asymmetric information and uncertainty associated with dryland salinity
- Policy mechanisms for salinity management
- Prioritisation of salinity investment under uncertainty
- Presentation of a selection of cases studies

The planned registration fee is in the region of \$75 including lunch, coffee/tea/snacks and proceedings.

The Workshop will be of great value to any economists, policy analysts, bio-physical scientists, modellers, and other people interested in or working on dryland salinity. It provides a unique opportunity to enhance knowledge in this demanding topic. Its timing as a prelude to the AARES 2003 Conference allows delegates to combine two top quality professional activities.

47th Annual Conference of the Australian Agricultural and Resource Economics Society

12-14 February 2003, Fremantle, Western Australia

AARES 2003 is a great opportunity to catch up on the latest thinking in agricultural and natural resource economics. The conference will be held in the 19th Century port city of Fremantle where history, heritage, culture and art come together. As well as exploring Fremantle, delegates might also like to visit some of the attractions that the rest of Western Australia has to offer, such as Rottnest Island and the Margaret River wine region, located in the south-west of the state.
