

#### **Publish in AJARE with Open Access!**

Publication fees can be a factor in determining the destination for a research publication. There is some good news. Many AARES members are likely to be eligible to publish articles in AJARE under Open Access with no transactional Article Publication Charges (APC) as part of Wiley's Council of Australian University Librarians (CAUL) agreement. #### New prize for a best paper by an ECR!

The AARES Prize for best AJARE article by an Early Career Researcher (ECR) is awarded to the most outstanding paper published in each volume, on which the lead author is an ECR. In the year of submission, the ECR author must be a current student or be within 5 years of their most recent graduation. This award comes with a certificate, A\$500 in prize money and a A\$250 Wiley book voucher. AARES Membership (https://www.aares.org.au/membership/joining-aares) is required for eligibility for this prize.
